OUR DEMONSTRATION FOREST PROJECTS

Charles Clark Forest Reserve – The remainder of our trail clearing work was completed in December! Now that the trails have been carved out, the next step will be to smooth and prepare the ground so it is more suited for hiking.

Walker Road Managed Forest – Some additional minor maintenance work was done on this property, although we concentrated the majority of our efforts on the Charles Clark property.

OUR RESTORATION PROJECTS

In 2021, we planted 4,995 trees in shelterbelt projects in Saskatchewan, and 5,130 trees in a creek restoration project in British Columbia. These projects were funded by various corporate and public sponsors.

OUR PUBLIC PARK PROJECTS

In 2021, we participated in tree planting programs in the following public parks:

Blomidon Provincial Park – We planted 8,487 trees in this park in Nova Scotia, where Trees For Life was the lead proponent and sponsor of the project.

Caribou-Munroes Island Provincial Park – We planted 9,458 trees in this park in Nova Scotia, where Trees For Life was the lead proponent and sponsor of the project.

Five Islands Provincial Park – We planted 12,490 trees in this park in Nova Scotia, where Trees For Life was the lead proponent and sponsor of the project.

Murray Beach Provincial Park – We planted 10,590 trees in this park in New Brunswick, where Trees For Life was the lead proponent and sponsor of the project.

Mactaquac Provincial Park – We planted 48,564 trees in this park in New Brunswick, where Trees For Life was the lead proponent and sponsor of the project.

Hopewell Rocks Provincial Park – We planted 11,855 trees in this park in New Brunswick, where Trees For Life was the lead proponent and sponsor of the project.

Terra Nova National Park – We planted 1,680 trees in this park in Newfoundland, funded by various public and corporate sponsors.

PEI National Park at Greenwich – We planted 8,000 trees in this park in Prince Edward Island, where One Tree Planted was the lead proponent and sponsor of the project.

Victoria Park – We planted 42,230 trees in this municipal park in Truro, Nova Scotia. One Tree Planted was the lead proponent for the project and sponsored the planting of 35,000 trees. We also planted an additional 7,230 trees that were funded by various public and corporate sponsors.

Parlee Beach Provincial Park – We planted 2,500 trees in this park in New Brunswick, where TreeEra was the lead proponent and sponsor of the project.

We expect to be planting in more than a dozen federal, provincial, and municipal parks in 2022.

OUR CARBON PLANTATION PROJECTS

A portion of our work in 2021 involved planting trees on carbon capture properties. These carbon plantations are properties which are reserved solely for carbon sequestration. We plant a diverse species mix on these plantations with the intent that they will be allowed to grow to maturity, and then remain undisturbed in perpetuity.

In 2021, we planted a total of 111,125 trees on carbon plantation projects.
